



## 20 Year Material Performance Warranty

1. Acrysystems Laboratories, Inc., 101 N. Prospect St., Reading, PA 19606 (the "Warrantor") hereby warrants to the purchaser of this AcryLabs product subject to the terms, restrictions, and conditions of this limited warranty, for a period of twenty (20) years (the warranty period) from the date of purchase.
2. Subject to the other restrictions in this Limited Warranty, if, upon the Warrantor's inspection, it determines that failure during the Warranty Period resulting solely from a defect in this AcryLabs product, the Warrantor's liabilities and obligations hereunder, and the purchaser's remedies hereunder, shall be limited to the Warrantor providing replacement product(s) of the Warrantor (consisting solely of this AcryLabs product or other Warrantor products of a substantially similar quality, in the Warrantor's sole discretion).
3. This Limited Warranty is valid only if: (a) this product is installed and maintained in strict accordance with all instructions and specifications of the Warrantor; (b) the purchaser has provided the Warrantor with written notice of any failure, noticeable damage or other problems with the product as promptly as possible and in no event later than ten (10) days of the discovery thereof; (c) all fees pertaining to the Project, the AcryLabs Products and the Limited Warranty due to the Warrantor and or the Applicator have been paid in full; (d) the purchaser has permitted the Warrantor to inspect the project. Additionally, this Limited Warranty shall not apply if any failure or damage is caused by any circumstances other than a defect in this product, including (without limitation): damage from vandalism, the acts of any person other than the Warrantor (or its agents or employees), ponding or standing water, falling objects, downed trees or branches, animals, plant life, fire or other casualties; defects in or failure of the project, any building thereof, any parts thereof or any substrate materials or their installation; Other contractor equipment or alike; lightning, hurricanes, tornadoes, earthquakes, hail, floods, tropical storms or other natural disasters; improper care, maintenance or repair by any other person other than Warrantor (or its agents or employees); failure of the purchaser to follow the care and maintenance instructions of the Warrantor, including (without limitation) periodic cleaning or drainage howsoever caused.
4. Except for providing replacement products in accordance with section 2 above and as limited by the other terms and conditions of this Limited Warranty, the warrantor shall not be liable for any other expenses, claims or damages of any kind howsoever caused, including, without limitation, any labor or other installation or product replacement costs and/or any direct, indirect, consequential, incidental, or special damages whether resulting from leaks or otherwise. This Limited Warranty does not cover discoloration or any changes to the color of the project roof or the AcryLabs product. This Limited Warranty replaces all other representations, warranties, guarantees or conditions, expressed or implied, statutory, or otherwise, of the Warrantor with respect to this product, and there are no other representations, warranties, conditions or guarantees, express or implied, with respect to this AcryLabs product or the manufacturer or installation thereof, including, without limitation, any warranty of merchantability or fitness for a particular purpose.
